I . Mission:

The Taoyuan International Art Award aims to cultivate talent in contemporary art and create a strong foundation for the research and creation of contemporary art, as well as to expand global perspectives, strengthen international exchanges, and encourage the diversified development of art practices.

- II . Advisers:** Taoyuan City Government, Taoyuan City Council, and Department of Cultural Affairs, Taoyuan
Sponsor: Taoyuan Museum of Fine Arts

III . Dates:

Organized once every two years.



- IV . Venue:** Taoyuan Arts Center (See Appendix 2 for venue details)

V . Eligibility:

- A** Artists may participate as an individual or a group. There are no limits on nationality. Simultaneous registrations in both the individual and group categories are prohibited. However, this restriction does not apply to those participating as working members of other teams.
- B** Works must be new pieces presented to the public for the first time and have never entered government-organized competitions in Taiwan.

VI . Registration Instructions:

A Entries:

- 1** Submitted entries are not limited in material, category, or size.
The space for an individual exhibit is in principle no larger than 600(L)×600(W)×250(H)cm. Taoyuan Museum of Fine Arts (TMOFA) will provide the finalized dimensions upon the announcement of the selected artists. The TMOFA reserves the right to adjust the display space according to the exhibition space planning.
- 2** Each individual/group is limited to registering one piece (or set) of work. Once registration is confirmed, changes are not allowed.
- 3** Works that pass the preliminary review must be displayed during the final review according to the exhibition plan submitted at registration. (For details on plan execution, please refer to Appendix I).

B Registration:

- 1** Online Registration
 - (1)** Go to the website of the Taoyuan International Art Award (tmofa-tiaa.com) to fill out the registration form and upload the entry work and exhibit plan. Submissions with incomplete information will not be accepted.
 - (2)** Entry work and exhibit plan:
The entry may be presented with texts, images, or videos. The content must include: photographs or schematics of the work, an artist statement, the work dimensions, the exhibit space planning, the equipment requirements, technical requirements, and the timetable for build-up and breakdown.
- 2** Specifications of entry:
 - (1) 2D work: painting/photography/mixed media**
One full image of the work (juxtaposed shots for a series of work) and 2-4 partial images. Use the title of the entry as the file name.
 - (2) 3D work: sculpture/3D object/installation/pluridisciplinary works**
One full image of the work and 2-4 partial images (including top view, front view, and side view). Use the title of the entry as the file name.

(3) Video and Interactive Works:

- a. audio/moving image/animation:
- (a) one complete version of the entry;
 - (b) one condensed video (3 minutes or less) ; and
 - (c) three static images (audio entries are exempted).
- b. Interactive Works:
- (a) Presentation video (limited to 3 minutes).
 - (b) Still images of the artwork (1-3 pieces) ; and
 - (c) Diagrams of the display method and interactive installations (1-3 images).

(4) Requirements for file format and the uploading process:

- a. Image files must be in jpeg format and under 2MB in size; video files must be submitted as a YouTube or Vimeo link; and
- b. The name of artist cannot appear in any videos.

VII. Judging Process:

A Preliminary Review: A jury panel will conduct the review; the list of the selected artists will be released on the official website of TMoFA.

B Final Review:

- ① On-site Review: The jury will conduct a review on the built-up works on site.
- ② Interview: Participating artists (or a representative of the group) in the Final Review shall attend the interview in person to respond to the inquiries from the jury members.

VIII. Rewards:

A Grand Prize *1: A prize of TWD 600,000, one trophy, one award certificate, and five albums.

B Honorable Mention *3: A prize of TWD 200,000, one trophy, one award certificate, and five albums.

C Sojourn Award *1: A subsidy of TWD 350,000 for a tour abroad is offered to a Taiwanese participant, one trophy, one award certificate, and three albums. The awardee is obliged to complete his/her sojourn within 2 years after the end of the exhibition. After returning to Taiwan, the awardee shall present a written report (the electronic copy will be published online) and certificates of flight ticket issuance.

D Selected Award: One award certificate and three albums.

❖ Taxes are included in the aforementioned amounts pursuant to the relevant regulations governing taxes in Taiwan.

❖ Please be advised that the actual amounts of the prizes are subject to the budget approved by Taoyuan City Council.

❖ The times and venues in this table are tentative; TMoFA may make and publicly announce changes as it sees fit.

X. Annex:

- A** The jury panel comprises professionals invited by TMoFA. The judging process shall be conducted pursuant to the provisions governing recusal in Article 32 of the Administrative Procedure Act.
- B** A list of group members is required for group works, from which a representative should be designated to exercise relevant rights and obligations in the competition.
- C** Participants hereby consent that the selected entry can be utilized by TMoFA for nonprofit purposes in any form, including education, research, exhibition, photography, promotion, public display, public transmission (online), production of album CDs and promotion materials, or editing, free of charge, with no limit on the means nor number of uses thereof.
- D** Upon the completion of online registration, the participant is deemed in agreement and in compliance with the provisions stated herein.
- E** TMoFA is to observe the duty of care for the exhibits during the duration of the Exhibition, while the participants are liable to pay due attention to the safety of the exhibits and displays. In the event of damage to a work incurred by force majeure or a reason not attributable to the Organizer, TMoFA is exempted from the liability of damage thereto.
- F** TMoFA is not responsible for the execution of any participatory art on site on behalf of participants; the requirements, technologies, and personnel relevant to the activity contents of public project(s) or on-site participation will be the sole responsibility of participants.
- G** Borrowing of any submitted entry during the duration of Exhibition is prohibited. The Organizer reserves the right to make adjustments to the display of a work according to the space planning and effect of the exhibition.
- H** Any of the following will result in disqualification of the participant from awards and prizes and a ban on participation in the Award for 3 years:
 - 1** Works that imitate, copy, or plagiarize from the work of a third party;
 - 2** Works that violate the Copyright Act or other relevant regulations; or
 - 3** Any severe violation of the provisions in the Prospectus.
- I** Visitors will be allowed to take photos of the works during the duration of the Exhibition. Nevertheless, video recording, flash photography, tripods, and selfie sticks are not allowed for the safety of the works.
- J** For any issues not addressed herein, the Prospectus may be amended with public announcements.

Appendix I: Detailed Regulations for the Final Review Exhibition

- A** Participants selected in the preliminary review should build up and break down their exhibits during the designated time at the designated space. The exhibition space will be coordinated and allocated by TMoFA. Failure to build up the exhibit in time will lead to disqualification.
- B** Participants will comply with the relevant regulations of the venue. Participants must restore the venue or to cover the restoration fee thereof in the event of any stains or damage to the venue by the aforesaid participants.
- C** TMoFA will cover the expenses of basic build-up, return transportation, and insurance of exhibited works as well as the transportation of the participating artists selected by the jury after the preliminary review:
 - 1** Basic build-up: Includes wooden partitions and stands, paint, electrical distribution, and so forth, with a budget cap of TWD 80,000. Expenses will be reimbursed based on actual costs, confirmed between the participating artists and the museum, and executed by the museum's designated contractors. Additional related costs, such as materials, equipment, tools, personnel, cleaning, and transportation and lodging during the exhibition setup, are the responsibility of the participants.
 - 2** Transportation and insurance for selected works:
 - (1)** The cost of transporting the work to the exhibition venue is the responsibility of the participant. (A letter of confirmation for exhibition selection, required for customs clearance, will be provided by the museum.)
 - (2)** The cost of transporting the work back will be paid by the organizer.
 - (3)** Insurance premiums: The comprehensive insurance policy for artwork will be provided by TMoFA to the extent from the artwork's arrival to the designated venue to the return transportation of entry works.

Each artwork is insured for a sum of TWD 500,000 (the insured amount does not equate to the artwork's price, if participants wish to increase the coverage, they may do so themselves). The insurance liability is based on the terms specified in the insurance policy.

③ Transportation costs for participants:

- (1) When attending events such as the "Final Review Meeting" and the "Awards Ceremony and Opening Press Conference," a subsidy covering one round-trip ticket by THSR or TRA train (Tze-Chiang Limited Express) between Taoyuan and the city/county of the place of artists residing in Taiwan.
 - (2) For foreign artists or those having lived abroad for over six months, the subsidy is up to an amount of TWD 60,000 to cover the roundtrip ticket of coach (economy class) to and from Taoyuan from the same location on a reimbursement basis. Only one representative from a group is eligible for the transportation subsidy.
- ❖ The transportation fee will be reimbursed afterwards. Kindly keep your boarding pass and any other certificate of ticket issuance.

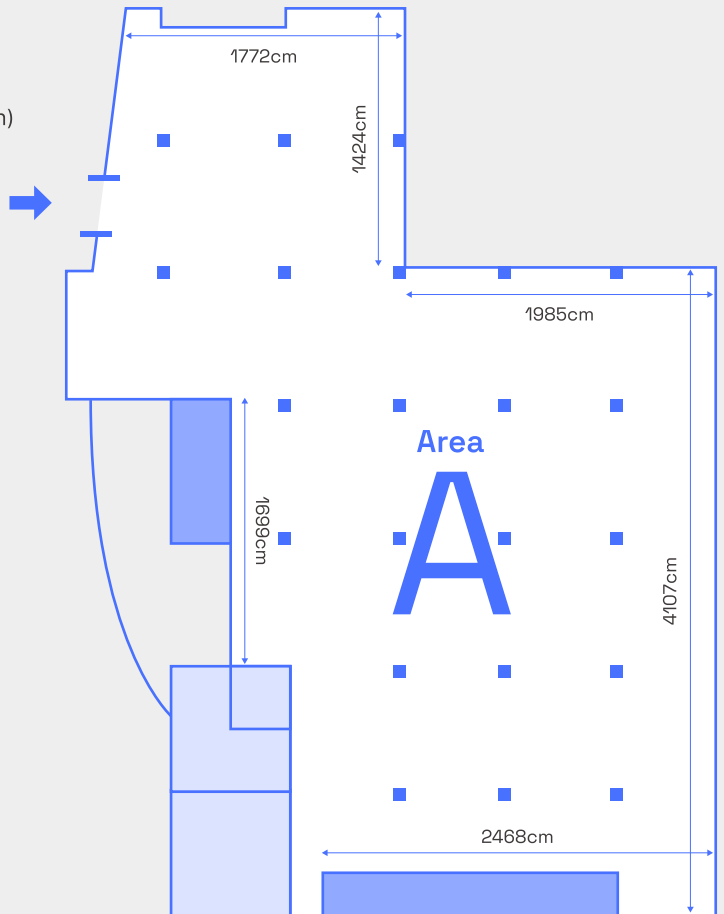

B Space Dimensions:

- ① The area of the venue is about 1653 square meters. Each artist will roughly occupy an area of "600(L)×600 (W)×250(H)cm" based on the preliminary estimation. The exact dimensions and arrangement of space for the exhibit will be announced by TMoFA upon the release of the list of selected artists.
 - ② The entrance to the exhibition is 175cm wide and 240cm high with a limit of 300cm high in the exhibition space.
- ❖ The exact dimensions and condition are subject to the latest information released by the Administrator of the space.

© Regulations of the Space:

The Administrator for the space of Taoyuan Arts Center is the Arts Facilities Management Center, Taoyuan City Government. The regulations governing the use of the space are as follows:

- ① Any adhesive that will leave traces or cannot be removed is prohibited on the wall surfaces of the space.
- ② Obstructing switch boxes, firefighting facilities, air-conditioning control panels, or safety signs is forbidden. No material or exhibits may occupy or block the passenger/freight elevators, emergency doors, and safe passages. Any object in violation thereof will be removed by the Administrator upon notice and failure to remedy by the exhibitor. The exhibitor shall be liable for expenses arising from the removal.
- ③ The following items are not allowed without prior consent from the Administrator:
 - (1) Use of nails or thumbtacks on the building or any hardware in the space;
 - (2) Hanging of objects from the pipelines in the ceiling of the space; and
 - (3) Posters or promotion materials on the walls or pillars.Any violation thereof and failure to remedy upon notice will result in removal by the Administrator. The violator shall be liable for compensation and restoration.
